

# The “Westside” Summer Skate Program 2010

The Westside Summer Skate Program is open to all high school age hockey players intending to try out for the Traverse City West High School Hockey Team in the fall of 2010. This ice time is not sponsored by the Traverse City West Senior High School or the Traverse City West Hockey Boosters. Space is **limited to 40 skaters and up to six (6) goalies on a first come, first serve basis.** To reserve your spot you must complete a registration form, and return with payment and Liability Waiver. There will be 16 skates during July and August which will include both 50 minute and 80 minute sessions. (See schedule below) Cost to participate is \$160.00 per skater which must be **PAID IN FULL IN ADVANCE**. Goalies will be pro-rated based on their ice time and participation per a separate schedule.

**DON'T DELAY! Reserve your spot now - ONLY 40 spots available.** You will be required to **make payment in FULL** and **return with a completed Registration Form and Liability Waiver prior to July 1<sup>st</sup>** to secure your spot. You will not be allowed on the ice without the necessary documents turned in - **NO EXCEPTIONS** (See page 3 for Waiver)

A limited number of “Pay to Play” spots will be available. The cost is \$15 per skate and must be paid before you get on the ice. A Liability Waiver is required for this option as well. This option must be arranged in advance with Paul Hanrahan – **NO EXCEPTIONS.**
